### 5.6 <u>AUCTION OF TENANCY RIGHTS OF SITE FOR PETROL PUMP MEASURING 14990 SFT</u> <u>SITUATED AT JHELUM ROAD RAWALPINDI.</u>

To consider the approval of the terms and conditions of site for auction of petrol pump situated at Jhelum road on the basis of tenancy rights.

It is mentioned that the site of PSO petrol pump at Jhelum road has been taken over from the PSO on 19-12-2018. Earlier, the case was placed before the board and the board vide CBR under reference resolved that the land in question be put to open public auction. The following terms & conditions of tenancy rights are proposed for consideration.

- 1. That only the firms/companies dealing with petroleum products / petrol / Diesel can participate in the auction.
- 2. That the site be auctioned on the basis of monthly rent through open public auction.
- 3. That Tenancy period will be for the period of 10 years.
- 4. That 10% rent will be increased in every successive year. The Board in its discretion and if it is agreeable to the tenant may extend the tenancy period for an appropriate duration on fresh rent after the expiry of tenancy period of ten years.
- 5. That tenant will himself erect the infrastructure existing/available at site at his own expenses and the same will not be claimed by the landlord / board.
- 6. That Fitting/fixtures/painting and other maintenance and repair etc of the premises will be done by the tenant at his own cost and tenant will have the right to take away the goods/building material etc after expiry of the tenancy period if belongs to tenant.
- 7. That the tenant will himself procure all NOC's / Permission from the concerned departments for establishing petrol pump at site.
- 8. The tenant will pay advance rent for six months within 10 days after approval of tenancy by the competent authority.
- 9. That in case of default in the payment for one month rent the landlord will automatically take over possession of premises by sealing the same without any notice to the tenant.
- 10. That in case of tenant's wish to discontinue tenancy before stipulated period he will serve three months' advance notice to the Board.
- 11. That in case of expiry of first term If the tenant is not willing to continue tenancy he will remove his own infrastructure one month before expiry of agreement in case his infrastructure is not removed due to un avoidable reasons he will apply to the board and the decision of board will be accepted by the tenant and he will pay rent in advance for the intervening period.

- 12. That if the tenant continually holds over possession after expiration or sooner determination of the tenancy, he shall be liable to pay of the rent as use and occupation charges.
- 13. In case of any dispute arising between the tenant and the Chaklala Cantonment Board, the matter will be referred to the President Chaklala Cantonment Board who will act as a sole arbitrator and his decision will be final.

Yds and minimum amount of composition fee should be imposed as Rs. 2,00,000/- in the light of HQ ML&C Deptt letter No. 75/853/Lands/92/14970/D-12/ML&C/94 dated 06-11-1994.
