2. Building Plans submitted by you for approval of the Board.

Your above referred building plan duly recommended by the building Committee in its meeting holding Resolution / /2019 approved by in board vide Resolution \_\_\_\_\_ date \_\_\_\_\_ with following terms and conditions.

- (a) Sanction is available for one year from the date on which it has been approval, and if the building is not started, within that period, it shall not thereafter be begun unless the Board (on application) has allowed an extension of that period.
- (b) Building shall be completed within one year of the commencement of the work or two years of the sanction of the plans.
- (c) If the erection or re-erection of the building is not completed within the periods stipulated in (a) above, fresh application shall be made to the Board for extension of period of completion. No more than two such extension shall be allowed by the Board in any case each and
- (d) Sanctioned plan shall be adhered to in from already approved plan every respect. Prior approval of the Board shall be obtained for deviation desired to be a made shall be obtained.
- (e) No building material shall be stacked on any public Road/street or Cantonment land without obtaining a licence from the Cantonment Executive Officer.
- (f) Drive in ramp if any shall be provided inside the holding and shall not disturb the level of the street or create any obstruction for the smooth flow traffic or rain water.
- (g) The driver in shall be provided with proper drainage into the adjoining drain through iron grating or other material to some save the road from erosion by out flow of water.
- (h) Corner of plot at the inter section of the streets shall be chamfered.
- (i) Building shall be used for the purpose for which it has been sanctioned. Conversion of the building for other purpose or purpose without the prior approval of the Board will make it liable to vacated and possession taken of the Board till it has rendered safe environmentally or otherwise.
- U) Work after DPC level will only be started after the inspection of site by the authorised rep; of Cantonment Board who will certify that the building is being constructed strictly in accordance with the approved Building Plan. In case of non verification of plinth at DPC level, onward construction will be treated as un-authorized.
- (k) Immediately after the completion of the construction the owner will apply to the cantonment board for a completion, on receipt of

3. It is a strict legal obligation of the owner that he/she will give a notice to the Executive officer within 30 days from the date completion or occupation, whichever is earlier. Owner/lessee, failing to give notice of completion shall be punishable under section 74(2) of Cantonments Act, 1924 with fine ten times of the amount of tax payable on building so erection in respect of a period of three months in addition to payment of tax from the date of completion or occupation whichever is earlier.

4. this sanction is only municipal point of view.

One copy of sanctioned building plans should be kept at the site of construction and should be produced by the person in charge at the site at any official of the Cantonment Board visiting the site.
