3.3 REQUEST FOR PERMANENT ABSORPTION AGAINST THE POST OF WATER SUPPLY SUPDT (BS-16) IN CHAKLALA CANTT

Reference/ Authority: Rule 4(2) of the Pakistan Cantonments Servants Rules 1954 and HQ ML&C Deptt letter No.92/1076/ADG(Est)/ML&C/2007 dated 19-04-2023.

To consider HQ ML&C Deptt letter No.92/1076/ADG(Est)/ML&C/2007 dated 19-04-2023 and request of Mr. Umer Hayat Khan Cantt Sub Engineer (BS-14) currently performing duties of Water Supply Incharge at Chaklala Cantonment Board for re-designation / upgradation as Water Supply Supdt (BS-16).

In this regard, it is apprised that above named official has pleaded that he is supervising extensive Water Supply System of CB Chaklala spread over 10 Wards Sectors including Askari Colonies and Defence Officers Housing Schemes at CB Chaklala with entire satisfaction of his superiors and residents of Chaklala Cantt. Water Supply Network of Chaklala Cantt consists of around 60 tubewells, 39 filtration plants and 25 kilometers of Water pipelines. The above said incumbent has experience and is well versed with the Khan Pur Dam and Rawal Dam Water Supply Network. He has also played vital role for replacement of damaged/dilapidated pipelines network system with new pipelines and that massive task accomplished with great hardwork and round the clock labour.

The case for re-designation / upgradation from Cantt Sub Engineer (BS-14) and permanent absorption as Water Supply Supdt (BS-16) was taken up with the ML&C Deptt for necessary sanction. In response ML&C Deptt vide letter under reference has conveyed to place the case before the Board if already not placed for creation of post of Water Supply Supdt (BS-16).

There is a dire need to create a local cadre post of Water Supply Supdt (BS-16) at CB Chaklala for effective provision of water supply / drinking water to approximately 0.679 Million of Civil population of Chaklala Cantt. Therefore, a full

time Water Supply Supdt (BS-16) is imperative likewise other Class-I cantonments instead of make shift arrangement and absorption / upgradation / re-designation of the applicant against the proposed post.

It is pertinent to mention here that there is a precedent case wherein ML&C Deptt has already accorded sanction vide letter No. 92/698/ADG(Est)/2006 dated 25.03.2022 for upgradation / re-designation of Mr. Muhammad Ayaz. Cantt Sub Engineer (BS-14) against isolated/local cadre post of Water Supply Supdt (BS 16) at CB Walton. His request may be considered keeping in view of the following facts:-

- a. Mr. Umer Hayat Khan is already working as Incharge Water Supply Section and his performance is satisfactory.
- b. The post of Cantt Sub Engineer (BS-14) and Water Supply Supdt(BS-16) are both related to Engineering Cadre.
- c. The proposed post of Water Supply Supdt (BS-16) may be created at CB Chaklala for imparting effective water supply to the residents of Cantt Board Chaklala.
- d. The creation of post of Water Supply Supdt (BS-16) and absorption re-designation / upgradation of Mr. Umer Hayat Cantt Sub Engineer (BS-14) against the proposed post shall have no impact on the Recruitment and Promotion Policy 2020 as the post of Water Supply Supdt (BS-16) is local cadre post having no career progression.

As per Rule 4(2) of the Pakistan Cantonments Servants Rules 1954, the DG ML&C is the Competent Authority to grant sanction for creation of post from BS-07 and above and re-designation / upgradation. The same is reproduced as under:-

"No alteration in the strength, designation and scale of pay of any Cantonment Servant in BS-07 and above shall be made without the sanction of the Director General."

In this regard, it is apprised that the draft building bye laws were prepared keeping in view of the modern construction practices and as per the directions of ML&C Deptt to standardize the existing building bye laws which do not meet the

present requirements of building construction and CCB is facing multiple issues in approval of residential and commercial building plans. Draft of standardized Building Bye-Laws of Chaklala Cantonment Board have also been vetted by CLA CCB.

It is further apprised that as per directions contained in HQ ML&C Deptt Rawalpindi letter under reference, the President Chaklala Cantonment constituted a committee to scrutinize, evaluate and examine the proposed building bye-laws and its impact on CCB infrastructure. The committee meetings were held on 01-01-2024, 08-01-2024 and 29-01-2024 for the purpose and after thorough persual and scrutiny the above committee furnished its detailed report/recommendations as per proceedings. Subsequently upon receipt to recommendations the proposed / amended building bye-laws were placed before the Board and the Board vide CBR No.5 (5.3) dated 22-02-2024 unanimously approved the same alongwith inclusion of second floor for residential building for further necessary action. Upon approval by the Board same has been published in national dailies "The daily Pakistan" dated 20-03-2024 and The News, Daily Dunya News dated 22-03-2024 for inviting suggestions and objections. An objection has been received regarding inclusion of second floor in residential buildings which would burden existing municipal infrastructure.

Foregoing above, the proposed amended building bye-laws are placed before the Board for approval. After approval of the Board the same will be forwarded to the Competent Authority for further necessary action.
